RECORD OF INTER-SCHOOL RACES FOR FIRST CREWS

THE BLACKMORE SHIELD

Presented by the late E. G. Blackmore, Esq., in 1893 for competition between Prince Alfred College and St. Peter's College. Rowed in fours on the Port River from 1893–6, and won each time by S.P.S.C. The race then lapsed until 1931, when it was transferred to the Torrens and rowed in eights. Between 1931 and 1958, when a special race was discontinued, the shield was won 16 times by S.P.S.C. and 11 times by P.A.C.
